AMENDMENT LETTER No 1

**STANDARD ADMINISTRATIVE ARRANGEMENT FOR MULTI-DONOR TRUST
FUNDS AND JOINT PROGRAMMES USING PASS-THROUGH FUND
MANAGEMENT**

Standard Administrative Arrangement

Between:-

**The Government of the United Kingdom and Northern Ireland, acting through
the Department for International Development (DFID)**

And;

The United Nations Population Fund (UNFPA)

Dear Klaus,

I refer to the Standard Administrative Agreement letter dated 29 October which you recently signed on behalf of the Multi-donor Trust Fund.

I would appreciate it if the following paragraph 1 and the Annex B could be replaced in the original version with the revised versions below so as to accurately reflect the financial commitment made by the Government of the United Kingdom and Northern Ireland, acting through the Department of International Development, and announced by our Minister Justine Greening on 3 November 2014.

Paragraph 1 to be replaced by new paragraph below:

Disbursement of Funds to the Administrative Agent
and the Fund/Programme Account

1. The Donor decides to make an initial contribution of £50 million (Fifty million pounds sterling) upon signature of this agreement and such further amounts up to a total sum of £75 million (Seventy five million pounds sterling) as it may decide (hereinafter referred to as the "Contribution") in the future to support the Fund. Payments of additional contributions are expected to be as follows; £15 million (Fifteen million pounds sterling) in December 2014 and £10 million (Ten million pounds sterling) in 2015 on basis of need (As per revised Annex B). The Contribution will enable the Participating UN Organizations to support the Fund in accordance with the TOR, as amended from time to time in writing by the Steering Committee. The Donor authorizes the Administrative Agent to use the Contribution for the purposes of the Fund and in accordance with this Standard Administrative Arrangement (hereinafter referred to as "Arrangement"). The Donor acknowledges that the Contribution will be co-mingled with other contributions to the Fund and that it will not be separately identified or administered.
