Memorandum of Understanding between the International Organization for Migration (IOM)

the United Nations Population Fund (UNFPA)
regarding the Operational Aspects of the Joint Programme Prevention of
Violence Against Women in Central America

This Memorandum of Understanding (hereinafter referred to as "MOU") is concluded between the International Organization for Migration (hereinafter "IOM"), an inter-governmental organization, established by treaty and having its headquarters at 17, Route des Morillons CH-1211 Geneva 19, Switzerland, and the United Nations Population Fund (UNFPA), a subsidiary organ of the United Nations, having its Headquarters at 605 Third Avenue, New York, as Administrative Agent of the Joint Programme Prevention of Violence Against Women in Central America, (hereinafter "Joint Programme").

WHEREAS, the Participating UN Organizations to the Joint Programme have signed a Memorandum of Understanding relating to the Operational Aspects of the Joint Programme (attached Annex I hereto).

WHEREAS, IOM wishes to participate in the Joint Programme and receive funds on the same terms as the Participating UN Organizations.

WHEREAS, the Participating UN Organizations and Donors to the Joint Programme agree to IOM's participation in the Joint Programme.

WHEREAS, the Participating UN Organizations authorize UNFPA as Administrative Agent to conclude this Memorandum with IOM for its participation in the Joint Programme.

NOW, THEREFORE, IOM and UNFPA hereby agree as follows:

- 1. IOM warrants and confirms that it has entered into relevant basic agreements with the governments of the countries where it will operate in connection with the Joint Programme, as a basis for its activities.
- 2. IOM warrants and confirms that as per its Constitution, IOM shall enjoy such privileges and immunities as are necessary for the exercise of its functions and the fulfillment of its purposes. All of the countries covered under the Joint Programme are Member States of IOM and have accepted its Constitution.
- 3. IOM agrees to carry out its activities on the terms and conditions of the Memorandum of Understanding entered into between the Participating UN Organizations and UNFPA attached hereto as Annex I, which is an integral part of this MOU.

- 5. This Memorandum shall enter into force upon signature by the authorized officials of IOM and UNFPA and shall continue in force and effect until it expires or is terminated.
