While there is no strict scientific definition of climatic disasters, the *World Disaster Report 2008* notes that climatic disasters are weather-related and include most of the hydrometeorological disasters, such as floods, cyclones, storms, extreme temperatures, drought, and wildfires, while avalanches, landslides and mudslides may be related to a mixture of climatic and geological factors.
