Recommendation 7: UNFPA CP should shift its focus to capacity development at the national and sub-national levels, complemented by attention to promoting an enabling environment. With capacity development as a major means of engagement, sufficient attention will need to be paid to capacity assessments at the level of organizations and individuals concerned, to inform the process. As such there is substantial scope in capacity building and the initiatives identified in the current country programme such as introduction of new midwifery curriculum, RTI/STI and cervical cancer screening, demography course, quantitative and qualitative research should be pursued and institutionalized in line with the Strategic Plan (2014-17).
