*WHEREAS*

the United Nations Population Fund (UNFPA), the Pan American Health Organization (PAHO) and the United Nations Children's Fund (UNICEF) have developed a Joint Project entitled "Amélioration de l'état de la santé de la reproduction en Haïti", at an estimated cost of CAD\$18,984,000, which is amended for the third time as follows:

**Amendment:** this amendment no. 3 provides changes to the Annex A – JOINT PROJECT DOCUMENT and to the Annex B – SCHEDULE OF PAYMENTS IN CANADIAN DOLLARS without increasing the financial limitation of the Administrative Arrangement.

**Amendment no. 1:** provided for changes to the Annex B – SCHEDULE OF PAYMENTS IN CANADIAN DOLLARS, without increasing the financial limitation of the Administrative Arrangement.

**Amendment no. 2:** provided for changes to the schedule of payments and to other section of the Administrative Arrangement, without increasing the financial limitation of the Administrative Arrangement.

**Therefore, the parties hereto agree on the following:**

In Annex A – JOINT PROJECT DOCUMENT of the Administrative Arrangement, **REPLACE** « Amélioration de l'état de la santé de la reproduction en Haïti MSP/UNICEF/OPS-OMS/UNFPA 2008-2013 (Nov. 2007) » **WITH** « Amélioration de l'état de la santé de la reproduction en Haïti MSP/UNICEF/OPS-OMS/UNFPA 2008-2014 (Déc. 2010) »
2. In Annex B – SCHEDULE OF PAYMENTS IN CANADIAN DOLLARS of the Administrative Arrangement, **REPLACE** the table in its entirety **WITH** the following table.
