<p>Evidence utilized in the design of the costed plan</p>	<p>The Costed Evaluation Plan for UNFPA Somalia 4th Country Programme of Cooperation was informed by the annual programme review of the 3rd country programme 2018-2020. In addition, it benefited from the ongoing 3rd country programme evaluation (CPE) exercise, through some main preliminary findings that have been provided by the CPE team. Moreover, this Costed Evaluation Plan has relied on (a) UNFPA Evaluation Office guidance on preparing costed evaluation plans (November 2018); (b) UNFPA evaluation policy 2019, with special attention to the key features of the policy i.e. enhanced focus on the use of evaluations, greater emphasis on UN coherence through joint evaluations, system-wide evaluations, UN Evaluation Group, and Inter-Agency Humanitarian Evaluation; and (c) the UNFPA Evaluation Handbook 2019.</p> <p>It has also relied on thematic evaluations that the Somalia CO selected either as case study or as a joint evaluation in specific areas such as: (i) the Evaluation of the UNFPA Capacity in Humanitarian Action; (ii) the Evaluation of UNFPA Support on GBV and Harmful Practices; (iii) the Evaluation of the UNICEF-UNFPA Joint Programme to End Child Marriage; and (iv) the Evaluation of the UNICEF-UNFPA Joint Programme to Abandon FGM. These evaluations have informed this Costed Evaluation Plan regarding some critical areas of concern such as harmful practices in Somalia, in particular FGM and child marriage, as well as shed light on the UNFPA humanitarian capacity within the context of the development-humanitarian-peace building nexus in Somalia.</p> <p>Furthermore, the costed evaluation plan was informed by the Somalia National Development Plan 9 (2020-2024); UNFPA Strategic Plan 2018-2021; and ICPD+25 national commitments.</p>
