Item 1 Organizational matters

Item 2 Structured funding dialogue

Under this item, the Board will have before it the report on the annual review of the financial situation, 2017, and the report on the status of regular funding commitments to UNDP and its funds and programmes for 2018 and onwards.

The report on the annual review of the financial situation undertakes a comprehensive review and analysis, from the financial perspective, of UNDP activities at the global and aggregate levels. The overview assesses the performance of the organization against the various sources for programming: UNDP regular resources, other resources, and UNCDF, and provides the financial position at the end of 2017 with illustrative comparators to the previous year.

The Board will also have before it a report on the status of regular funding commitments for 2018 and onwards, and a summary of contributions to regular and other resources received in 2017 for UNDP, UNCDF, and UNV. This year's report shows continuing support for UNDP as evidenced by a one per cent increase in total resources from 2016, and a four per cent increase in total resources from 2014. However, these increases are accompanied by a decline in regular resources, and a high concentration of highly earmarked other resources. The report also highlights the lack of predictability of regular resources with less than 30 per cent of annual contributions backed by multi-year commitments, and a limited number of core contributors with the top 10 accounting for 86 per cent of total contributions in 2017. The report makes a case for why regular resources are important, and outlines UNDP efforts to explore incentives and mechanisms to broaden the donor base and encourage donors to shift to less restricted other resources aligned to the Strategic Plan.

Item 3

Gender equality at UNDP

The UNDP gender equality strategy, 2018-2021, is the third such strategy. It articulates the core principles and priorities of UNDP and provides entry points for achieving the gender equality targets across the three development settings of the UNDP Strategic Plan, 2018-2021. This strategy also identifies priority areas for signature solution 6 of the Strategic Plan, strengthen gender equality and the empowerment of women and girls. This strategy reflects the recommendations and the UNDP management response to the 2015 evaluation of UNDP contribution to gender equality and women's empowerment. The strategy is aligned to the requirements of the United Nations System-wide Action Plan on Gender Equality and the Empowerment of Women and to the common chapter of the strategic plans of UNDP, the United Nations Children's Fund, United Nations Entity for Gender Equality and the Empowerment of Women (UN-Women) and United Nations Population Fund. The Board may wish to adopt a decision, elements of which are contained in the report.

**Item 5
Evaluation**

The Independent Evaluation Office (IEO) of the United Nations Development Programme (UNDP) has carried out an evaluation of UNDP inter-agency pooled financing services. The evaluation is part of the IEO multi-year evaluation plan (2018-2021), approved by the Executive Board at its first regular session 2018. The objectives of the evaluation were to assess the effectiveness and efficiency of UNDP in providing inter-agency pooled financing services through the Multi-Partner Trust Fund Office; and to provide findings, conclusions, and recommendations to improve and inform UNDP positioning as a provider of inter-agency pooled financing services. The evaluation assessed the extent to which UNDP management of pooled funds responds to the concerns of its two primary partners - the contributing donors and participating United Nations organizations - and contributes to the policy purposes for which the Multi-Donor Trust Fund/Joint Programme financing instrument was established, in particular: increased donor harmonization; improved United Nations programme coherence; improved inter-agency coordination; and increased incentives for collaboration within the United Nations development system. In addition, the evaluation sought to better understand the donor choice among funding mechanisms, and under what conditions donors do or would prefer the Multi-Partner Trust Fund Office administer United Nations pooled funds. The evaluation, and the accompanying management response, are expected to inform how the UNDP Multi-Partner Trust Fund Office strategically positions itself as a preferred provider of inter-agency pooled financing services in support of the Sustainable Development Goals.

The Board will also have before it an evaluation of UNDP inter-agency operational services. The evaluation is part of IEO multi-year evaluation plan (2018-2021), approved by the Board at its first regular session 2018. The objectives of the evaluation were to assess the effectiveness and efficiency of UNDP in providing inter-agency operational services and to provide findings, conclusions, and recommendations to improve and inform UNDP contributions as a provider of inter-agency operational support services. The evaluation covered the period 2010 to 2017, and the scope of the evaluation looked broadly at the operational structures in place and assessed whether UNDP is managing these operational services effectively and efficiently, while meeting the needs and expectations of the United Nations agencies receiving this support at the global, regional and country levels. While the evaluation takes note of the ongoing United Nations development system reform, the team has not tailored its findings, conclusions and recommendations to the envisioned reforms, as they are yet to be finalized. The evaluation, and the accompanying management response, are expected to inform how UNDP strategically positions itself as a preferred provider of inter-agency operational services in support of the Sustainable Development Goals.

Item 6

UNFPA structured funding dialogue

The Executive Board will hold a structured funding dialogue within the context of the sustainable development goals and the evolving financing landscape. UNFPA will report on its efforts to continue to explore incentives, mechanisms and funding windows to broaden its donor base, improve communications with donors, and continue dialogue on options that will enhance the quality of contributions to finance development results.

In accordance with decisions 99/5 and 2000/9, requesting the Executive Director to provide annually updated estimates of regular and co-financing resources, the report presents the funding commitments of Member States and others to UNFPA and projections for 2018 and future years.

An addendum to the contributions report outlines a proposal to improve the structured funding dialogues, as requested by the Board in decision 2017/25.

Item 9

United Nations Office for Project Services

In its resolution 39/220 the General Assembly established the need for recurrent reporting of statistical data on procurement by United Nations agencies on operational activities. As of 2008 and pursuant to Executive Board decision 2007/38, the Executive Director of UNOPS has assumed the responsibility of compiling and submitting the report. The current report presents an analysis of the \$18.6 billion of goods and services procured by 40 United Nations organizations in 2017. The Board may wish to take note of the report.

Financial, budgetary and administrative matters

The joint UNDP, UNFPA, UNICEF and UN-Women report on cost recovery is prepared in accordance with decisions 2017/11 and 2017/14 of the UNDP/UNFPA/UNOPS Executive Board, which requested UNDP, together with UNFPA, UN-Women and UNICEF, to continue the consultations with Member States with regard to the cost-recovery policy and to present evidence-based proposals for harmonized cost-recovery policies of UNDP, UNFPA, UN-Women and UNICEF, with adjustments if required, for consideration by the respective Executive Boards no later than their annual sessions in 2018. It is recalled that a draft joint report had been shared with the Executive Board in April 2018. Subsequently, the Executive Board has agreed to postpone the formal consideration of the joint report on cost recovery to the second regular session 2018.

The report of UNDP, UNFPA and UNOPS on joint procurement activities outlines key findings and outcomes from the common procurement work conducted in 2017, and sets out the initiatives under way in 2018. UNDP, UNFPA and UNOPS began assessing opportunities for common procurement initiatives in January 2011. The goals were more efficient processes, strengthened procurement practices, and lower costs for all participating agencies. The report now provides details on the diversity and nature of joint procurement across the three agencies, covering a range of products and sectors, in direct support of projects and programmes. The Board may wish to take note of the present report and comment on the joint procurement activities delivered in 2017, as well as activities in progress in 2018.
