Why?

- QBEP is a rolling plan, flexible and responsive to the changing context.
- It is periodically revised to ensure its constant relevance to the organization, its goals and the evolving external environment.
- To facilitate a balanced approach between strategic coverage and utility of evaluation, the plan covers four years. Firm proposals are presented for 2022-2023, with indicative proposals for 2024-2025 to be validated in 2023.

What is its scope?

- ✓ Evidence-gap analysis conducted by assessing the coverage of corporate evaluations managed during 2015-2021 against the outcomes of the UNFPA strategic plan.
- ✓ Consultations with major stakeholders held to assess their relevance and utility
