## **Note by the Executive Director**

Summary

The present note contains information on the one-year extensions of the UNFPA country programmes for Paraguay and Venezuela.

In accordance with established procedures, the Executive Director approves the first one-year extension of a country programme, while requests for second one-year extensions or requests for two-year extensions are submitted to the Executive Board for approval.

Paraguay	2007-2013	2014	The United Nations country team and the Government have agreed to extend the United Nations Development Assistance Framework (UNDAF), 2007-2013, for one year, through 2014. This will enable the UNDAF to be aligned with the new government administration, which will take office in August 2013, and with the new national development plan. UNFPA will likewise extend its country programme for one year, in order to ensure alignment with government planning processes.	The next presidential election will take place in April 2013; a new administration will take office in August 2013. The new administration is expected to adopt a development plan that the United Nations system will take into account in developing the next UNDAF. The United Nations country team considers the alignment with the new government plan, national priorities and public policies to be of critical importance.
