WHO DEFINITION OF INTERCHANGEABLE PHARMACEUTICAL PRODUCT

An interchangeable pharmaceutical product is one which is therapeutically equivalent to a comparator product and can be interchanged with the comparator in clinical practice.

In practice, this means interchangeable products can be safely substituted with each other. Where national laws permit substitution with generic medicines, this guide can help inform decisions on which product to procure.
