Highlights

- To date, UNFPA has delivered 97 metric tons of sexual and reproductive health (SRH) supplies in Ukraine and Moldova. In Ukraine, 81 metric tons of essential health and medicine supplies were delivered to service delivery points across 38 referral level maternity hospitals, including emergency inter-agency reproductive health kits, medical supplies for maternal health, and other non-food items requested by health and other state facilities (16 metric tons have been delivered in neighboring Moldova, see below).
- An additional 70 mobile psychosocial support teams are now operating, bringing the total number to 101. The teams bring support to GBV survivors in 21 regions of Ukraine and facilitate access to services in the most hard-to-reach areas, rural districts and war-torn cities.
- A new Youth Orange Safe Space was opened in Moldova to provide life-saving support and protection for young Roma refugees from Ukraine.
- Documentation of the SRH needs and experiences of Ukrainian refugees – and the civil society organisations and human rights defenders supporting them – is underway in Hungary, Poland, Romania and Slovakia as part of a joint project with the Center for Reproductive Rights.



Situation Overview/ Humanitarian Needs

- As the war in Ukraine enters its sixth month, attacks in the country's south intensify. Some 12.1 million people are estimated to need health assistance, and 15.7 million require protection assistance and services in Ukraine. Some 6.6 million people remain internally displaced, and over 6.3 million refugees are recorded in European countries.
- As of 4 August, WHO had verified 434 attacks on health facilities, and access to health care remains challenging due to severe service disruptions and additional patient workload in western regions.

UNFPA Humanitarian Response*

- The new **Survivor Relief Centre** in Zaporizhzhia, Ukraine, opened four weeks ago, provided specialized services to **more than 520 people**, including **survivors of conflict-related sexual violence**. The centre serves as a safe space for survivors to receive medical, legal and psychological assistance.
- Over **1,200 women and girls** in Kyiv, Vinnitsya and Lviv received medical services and referrals through UNFPA-supported **reproductive health mobile teams**, totalling nearly 4,000 women and girls since April.
- A UNFPA-supported **online psychotherapy platform** in Ukraine received 54 cases of survivors of gender-based violence in July alone. Over 100 survivors have received consultations through the platform, including 18 cases of sexual violence.
- In **Moldova**, UNFPA equipped nine perinatal centers and medical institutions with instruments, life-saving drugs and supplies, including for the clinical management of rape, and provided related capacity building. Since the onset of the crisis, UNFPA distributed over 10,000 dignity kits to women and girls to address their special needs and ensure respect for their dignity and distributed over 16 metric tonnes of essential health equipment and supplies.
- In **Moldova**, UNFPA opened **Orange Safe Spaces** and mobile teams to offer women and girls from Ukraine immediate support and counseling. These spaces serve as an entry point for services and referrals related to gender-based violence and sexual and reproductive health. Over **4,000 women, youth, and older persons** have received services through **16 Orange Safe Spaces** across the country, including individual and group counselling, awareness raising on mental health issues and LGBTI rights, and referral to specialized gender-based violence services for further support.
- In **Belarus**, **Orange Safe Spaces** have been set up in two regions to provide psychosocial counselling and services to Ukrainian refugees through a network of national volunteers, with a focus on **women, older people and people with disabilities**.
- UNFPA distributed **121 post-rape treatment kits** throughout Moldova for adult and child GBV survivors and continues to deliver in-person training to SRH service providers in 27 medical institutions. More than **2,000 doctors have been trained on post-rape treatment, GBV and psychosocial support**.
- UNFPA facilitated debriefing and counselling sessions for frontline workers and volunteers at the Belarus Red Cross to **prevent burnout and inform them of available mental health services**.
- **Trauma support services and SRH awareness activities** were launched targeting young refugees and host communities in Romania, in collaboration with IPPF Romania and the NGO Youth 4 Youth.
